We expand our impact by communicating our presence and availability, and making sure that people know about the help we offer and are able to access the care they need when they need it. In June, 2024, Nebraska Governor lim Pillen joined us for the ribbon-cutting and opening of our new Center for Mental Health. More than a large and beautiful building, this new facility, located on a major street, near the interstate and serviced by multiple bus lines, has significantly increased our visibility and makes access to services easier for individuals throughout the community. The building is designed to accommodate the substantial growth experienced by Community Alliance over the past several years and that which is projected going forward. It also incorporates our learnings over the years, including best practices in providing integrated, whole person care.

IMPACT / ACCOMPLISHMENTS

The new Center for Mental Health enhances access to care by:

- Bringing our treatment, rehabilitation and recovery support services under one roof
- Providing walk-in appointments
- Adding telehealth capacity
- Extended evening hours

Service growth, visibility, and coordination was also expanded through building design and added physical space including:

- Additional individual and group therapy rooms for both mental health and substance use treatment
- · Dedicated health and wellness space
- Expanded number of exam and consultation rooms
- Staff "huddle" areas for team-based care
- · Designated area for family education and support services
- Future area for dental care services
- Enlarged day rehabilitation classrooms and activity areas
- Reflection room to enhance spiritual wellness
- · Large staff training and community meeting space

Our commitment to serving the whole person is embedded in our mission of helping people to live, work, learn and contribute within their circle of family and friends and as part of their **community.** We focus on wellness and purpose and we recognize that each person's path to recovery and well-being is influenced by their age, gender, beliefs, culture, relationships, and life experience. This is why we continuously strive for a more connected system of care that delivers integrated mental health, substance use and primary health care along with employment and community supports, the encouragement of peers, and help in accessing housing, financial and other resources. The positive impact of such an approach is measurable.

IMPACT / ACCOMPLISHMENTS

- Participants in Community Alliance's integrated primary care and outpatient psychiatric and counseling program showed **statistically significant improvements** in blood pressure, average breath carbon monoxide, and LDL cholesterol from baseline to reassessment.
- Within this same program, reductions in anxiety and depression were noted among participants, as were increased ability in managing work, school, and daily life and improvements in social connectedness with family, friends, and community.
- 97% of persons served by the organization's peer crisis diversion program reported improvement in dealing with their crisis situation and that the services received helped them avoid an emergency room or hospital visit.
- Among those served through reentry services, **91% did not recidivate** while enrolled in the program.
- 95% of all persons served over the course of the year were **supported in the community without psychiatric hospitalization**.
- Outreach and support to veterans and their families was extended by Community Alliance through its offering of a free, seven-week educational program for families, caregivers and friends of military service members and veterans based on the NAMI Homefront curriculum.
- Inquiries and requests for services received by Community Alliance increased by nearly 25% on an annualized basis when compared to the prior year.
- 95% of persons served reported **satisfaction with Community Alliance services**.

The accomplishments achieved and impact experienced by those we serve would not be possible without the daily contributions of our workforce. Over the course of the year, Community Alliance employed 345 individuals. We are physicians, counselors, nurses, peers, case managers, care coordinators, skills trainers, job coaches, property managers, office and billing specialists, technology, human resource and accounting professionals, and more. Throughout the year, we worked to support and invest in our people so that they could support and invest in our clients and in our community.

IMPACT / ACCOMPLISHMENTS

- Employees participated in **over 10,000 hours of staff training and practice opportunities** in areas relevant to their positions, including trauma-informed care, principles of recovery, evidence-based practices, team-based service delivery, person- and family-centered care, and maintaining personal and consumer safety.
- Licensure supervision and support was provided to 16 employees holding provisional licenses to help them acquire full mental health, alcohol and substance use, or dual state licensure.
- 100% of the agency's **supported employment staff achieved certification** in the best practice Individual Placement and Support (IPS) model.
- Community Alliance conducted 3 week-long peer support classes, **graduating 69 participants** and preparing them for certification as Peer Support Specialists.
- We hosted **434 students**, **interns and residents** from 14 different colleges and universities, introducing them to career opportunities within the behavioral health field and allowing them to obtain practical experience applying knowledge learned in the classroom.
- Through planning and ongoing investment in technology throughout the year, we continued to enhance our client electronic health record, worked on increasing staff effectiveness and efficiency through mobile applications and faster connections, and boosted our cybersecurity measures.
- Activities supporting employee wellbeing, inclusive of all eight dimensions of wellness - Physical, Emotional, Intellectual, Occupational, Financial, Social, Spiritual, and Environmental - were offered throughout the year.
- Staff and consumer involvement alike was encouraged through **sponsorship in community activities** including NAMI Walks, AFSP Out of the Darkness Community Walk, Omaha Pride Parade, and more.

We expand our impact by prioritizing engagement with all aspects of our community including the individuals we serve, their families, those who are in need but we have not yet reached, and colleagues, organizations and citizens with whom we can partner. By reaching out and listening, we found the need to further expand services to better support individuals across the lifespan from children to adults, and to serve people seeking help for shortterm mental health challenges as well as those facing ongoing mental illness and substance use concerns. Our community outreach focused on collaboration, education, and advocacy across both public and private sectors, seeking out new partnerships while working to strengthen existing ones.

IMPACT / ACCOMPLISHMENTS

- Partnering with state and local government, we extended our outreach to provide reentry support for people with mental health needs who are justice-involved, and peer navigation services for those struggling with opioid use.
- We initiated a new Healthy Transitions program focused on identifying and helping youth and young adults navigate the transition into adulthood, and expanded employment opportunities and supports for those whose illness may have interrupted their vocational success.
- We continued to work with colleague organizations to address the growing numbers of **individuals and families experiencing homelessness** across our community.
- Community Alliance provided **education and support to 281 family members** and significant others during the year, with 82% reporting improvement in their ability to support their loved one as a result of their participation.
- More than 600 people participated in this year's Breaking the Silence mental health awareness event featuring 3rd generation mental health advocate Ali Astin, daughter of actor Sean Astin and granddaughter of Oscarwinning actress Patty Duke.
- **Bike with Mike**, organized by the Kutilek family in collaboration with Community Alliance in honor of Mike Kutilek, drew more than 425 people on a beautiful spring Saturday made memorable by biking, tacos, and shared information about mental health and the benefits of integrated care.
- Our continued outreach, education and advocacy led us to apply for and be **one of 7 agencies selected statewide** to participate in the initial cohort implementing the national Certified Community Behavioral Health Clinic (CCBHC) model in the State of Nebraska. Progress continues in this significant endeavor with state certification anticipated in 2025 and official launch in January, 2026.
